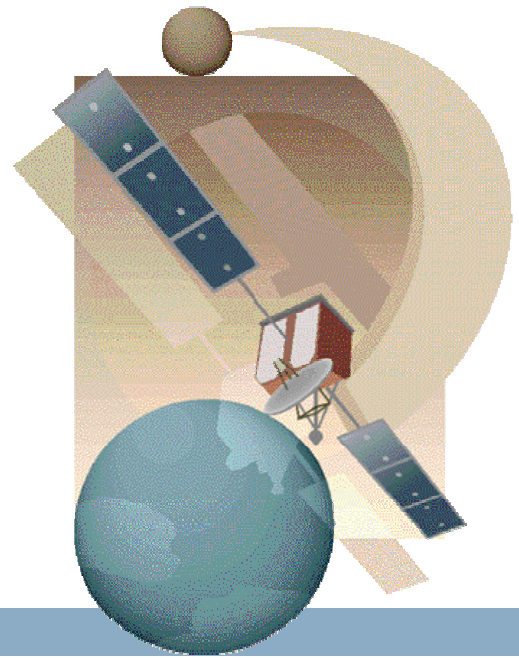

Description: New permanency legislation that will affect child welfare and Family Court practices across New York State has been passed by the legislature and is pending the Governor's signature. The provisions of the legislation will support the timely achievement of safety, permanency and well-being outcomes for children and families. To assist the New York State child welfare community in understanding the implications of this landmark legislation and preparing for its enactment and implementation, NYS OCFS will conduct two teleconferences. OCFS staff will provide an overview of:

- changes in how and when districts, agencies and Family Courts prepare for Permanency Hearings;
- changes to requirements related to protective removals and suspended judgements; and
- provisions for conditional surrenders; and impacts on CONNECTIONS.

Due to the scope of the Bill, the presentation will be delivered in two separate modules. The purpose of the first teleconference, **August 2**, is to review the content of the bill, the changes it will make to current procedures, and its impacts on district, agency and Family Court practices in these areas:

- Protective Removals
- Respondent Parents
- Continuing Jurisdiction and Date Certain calendaring
- Initial Permanency Hearings
- Initial Service Plan Review and case assessment and planning

The second teleconference, **August 9**, will address the content of the bill, the changes it will make to current procedures, and its impacts on district, agency and Family Court practices in these areas:

- Permanency Hearings
- Conditional Surrenders

- Termination of Parental Rights
- Service Plan Reviews and case assessment and planning
- Appeals

Audience Questions: During the course of the teleconferences, the audience will have the opportunity to fax or call-in questions, which will be addressed in the Question and Answer period of the teleconference.
